Experience

President, Nevada for Reproductive Freedom January 2024 – Nov 2024

- Led the effort to advance 1 of 10 statewide abortion ballot initiatives in the 2024 election cycle, successfully passing the initiative with 64% of the vote, higher than any other abortion-only initiative in the nation. Managed the campaign from inception in 2018 through successful passage.
- Managed high-performing campaign teams across many partner organizations. Providing coaching, mentorship and guidance along the way.
- Served as spokesperson for the campaign, handling all local and national media requests.
- Raised 10-million dollars for the campaign and oversaw high-level strategic spending efforts working with and developing key relationships with national funders.
- *Member of Steering Committee for ERA (2022) and Marriage Equality (2020) Ballot initiatives in Nevada.

Executive Director, Planned Parenthood Votes Nevada (PPVNV) May 2018 - May 2025

- Led the development of a non-partisan statewide plan for electoral, legislative, and other organizing campaigns including planning, implementation, and evaluation of PPVNV's overall mission and strategy.
- Provide operational leadership through continued development as a non-profit organization, ensuring a high level of professionalism for both the electoral campaign and the legislative session.
- In addition, managed all staff in Reno and Las Vegas, while maintaining a budget and financial systems to support a highly transparent organization. Worked to leverage all departments and resources to drive high-performance objectives for staff.
- Supported all administrative duties and work of the PPVNV Board for both 501c3 and 501c4, including financial management, board compliance, and programmatic responsibilities. Managing almost five budgets with expenses totaling well over a million dollars.
- Managed all planning, development, and implementation of a comprehensive public affairs strategy, including brand management, community outreach, and media engagement through earned, social, and traditional media outlets. Including the utilization of research tools (data and polling) to drive campaign strategy.
- Managed the endorsement process for all state assembly, senate, and municipal races in Nevada.
- Additionally, lifted and supported federal endorsements and corresponding candidates.
- Responsible for all grant writing, execution, evaluating and reporting from various funding sources.
- In 2023, raised almost \$800,000 in grants for programs at PPVNV, additionally identified grant opportunities for Nevada's health centers.
- Served as the lobbyist representing Planned Parenthood Health Centers, including determining legislative priorities, identifying bill sponsors, driving strategic partnerships, building grassroots advocacy and successfully navigating legislative processes and politics.
- Led litigation strategies for several Nevada petition initiatives, identifying funding and successfully delaying the signature gathering process for opposition groups.
- Managed all compliance activities and reporting for two PACs (both federal and state) as well as two different ballot committees within Nevada. Additionally, handled all reporting for the 2022 coordinated campaign in Nevada.
- Successfully secured 6 million dollars in the state budget for Family Planning Services and supported the passage of the first ever proactive abortion legislation in the state since 1990. At the same time, advanced partner legislation focused on patient care, increased Medicaid reimbursements, and legislation related to protections for the Affordable Care Act. Introduced the first abortion ballot question since 1990 in the state for the 2024 ballot.
